5962 Apologies

5966 Climate Change and Environmental Strategy

The Council received a proposed Climate Change and Environmental Strategy for consideration and adoption (item 5 on the agenda).

It was proposed by Councillor Nick Brown and seconded by Councillor Amanda Hack and was

RESOLVED that the Climate Change and Environmental Strategy, attached at Appendix 2 of the report, be approved and adopted.

Reason for Decision

To provide the framework for the Town Council to take action to respond to Climate Change and enhance the local environment.

5967 Announcements

a) Town Mayor

The Town Mayor, Councillor Darshan Singh announced that he had attended the Summer Fete on Saturday 7th August that it was very well attended and he thanked Councillors for their help on the day.

He also announced that he had attended Apple Day that was held on Franklin Park, 18th September. This had been very well attended and many local residents had enjoyed the event that included apple picking and juicing, dance display, animals and birds of prey.

The Town Mayor would also be attending the Blaby District Chairman's Hog roast in October.

b) Leader of the Council

The Leader of the Council, Councillor Nick Brown praised the success of Apple Day that was held on 18th September on Franklin Park and passed on the Council's thanks for the hard work that had made the event such a success.

The thanks of the Leader of the Council were supported by Councillors Amanda Hack and Sam Maxwell.

c) Executive Officer & Town Clerk

The Executive Officer & Town Clerk advised that Lateral Flow Kits were available from the Civic Centre for members to take home if required.

It was also noted that a briefing session on the new Councillor Code of Conduct followed by a question-and-answer session would be arranged on 30th September and members agreed to a start time of 5.30pm.

5975 Sealing of Documents

There were no documents for sealing.

5976 County and District Councillor Reports

a) Leicestershire County Council

Councillor Amanda Hack, as County Councillor for Braunstone Division, reported on the following matters:

- a) Leicester City consultation on transport and parking levy;
- b) Health Scrutiny panel to discuss changes to how NHS governed, residents' concerns regarding GP closures, children's A & E services;
- c) Climate Change commitment and details to be forwarded to the Executive Officer & Town Clerk; and
- d) Support for the division of Environment and Highways Scrutiny Committee.

Councillor Bob Waterton commented on parking around Millfield School and raised concerns of cars parking over emergency entrance gates.

Councillor Amanda Hack confirmed that monitoring was on-going with parking around the schools and that this issue was common around all schools.

Councillor Leanne Lee confirmed that the Millfield School newsletter reminds parents about parking and agreed to ensure that the message is reinforced to parents that the emergency gate must not be blocked by vehicles.

Councillor Shabbir Aslam advised that the County Council had removed double yellow lines around the area of Ravenhurst School that had caused issues with parking and traffic as the road is also a bus route and raised concerns with parents blocking residents' driveways.

Councillor Amanda Hack confirmed that the double yellow lines should have been reinstated and would look into this

Councillor Christian Startin-Lorent raised concerns about vehicles parking on pavements and preventing pedestrians using the pavement particularly around Meridian Business Park.

Councillor Louise Richardson, County Councillor for Enderby and Lubbethorpe Division, reported on the following matters:

- a) Footpaths – have spoken to the police about the problem of parking on pavements but will speak to them again and raise the issues in Thorpe Astley;
- b) Medium Term Financial strategy – reported issues with overspend;
- c) Leicester City transport and parking levy and the issues this could cause to areas on the edge of the Leicester City;
- d) School term dates now set;
- e) Cycle way between Meridian – Thorpe Astley – Braunstone Town meeting to raise concerns and points; and
- f) Health care consultations and concerns for what is best for residents – should be neighbourhood led rather than top down.

b) Blaby District Council

Councillor Sam Maxwell, as District Councillor for Ravenhurst & Fosse Ward, reported on the following matters:

- a) Three new working groups set up – Live- Work and Visit Blaby District. None of the three groups had yet met; and
- b) Boundary review in Blaby district to reduce number of councillors from 39 to 36. Officers at Blaby District council would be drafting up plans for boundaries and number of electors in each area.

Councillor Phil Moitt advised of his Chair of Blaby District upcoming events including a Hog Roast and 100-mile walk.

Councillor Ben Taylor, as District Councillor for Winstanley Ward, reported on the following matters:

- a) Boundary review;

- b) New Chief Executive of Blaby District Council, Julie Smith, had been recruited and would be in post later in the year;
- c) New Local Plan for Blaby District Council to go to public consultation in Spring 2022; and
- d) Blaby District Council Climate Strategy established and pleased to see Town Council's Climate Strategy and looked forward to collectively addressing the issue of Climate Change.

The meeting closed at 9.05pm.
